1b. A degree at MQF Level 6 in Education together with a minimum of eight (8) years teaching experience in the areas indicated in the table overleaf;

OR

- 1c. A degree at MQF Level 6 and PGCE with a minimum of eight (8) years teaching experience in the areas indicated in the table overleaf.
- 2. Communicate fluently in both Maltese and English.

Master of Education Degree

- 1. A Master's degree (subject to a minimum of 90 ECTS/ECVET credits, or equivalent) or a recognised, appropriate, comparable qualification at MQF level 7 or higher together with five (5) years teaching experience in the areas indicated in the table overleaf.
