With reference to the Letter Circulares [IfE 07/2019 – Expression of Interest for Practicum Visitors](#) and [IfE 16/2019 - Extension of Deadline: Expression of Interest for Practicum Visitors](#) whereby Practicum Visitors were being called to perform a number of visits per course participant enrolled with the Institute of Education, kindly note that the following amendment in the **Eligibility Criteria for Vocational Education and Training (VET) and Applied Subjects**:

Eligibility Criteria (VET and Applied Subjects)

The eligibility criteria for the selection of the **Practicum Visitor for VET and Applied Subjects** shall be:

- 1a. A Master degree or a recognised, appropriate, comparable qualification at MQF Level 7 (subject to a minimum of 90ECTS/ECVET credits, or equivalent) or higher with a minimum of (3) three years teaching experience;

OR

- 1b. A qualification at MQF Level 6 or equivalent in Education (subject to a minimum of 180 ECTS/ECVET credits or equivalent) or a qualification at MQF Level 6 (subject to a minimum of 180 ECTS/ECVET credits or equivalent) and a Postgraduate Certificate in Education (PGCE) with a minimum of (5) five years teaching experience;
2. Communicate fluently in both English and Maltese.

All applicants require;

- A Permanent Teachers' Warrant;
- A *Europass Curriculum Vitae* and motivation covering letter explaining the reasons of interest for providing this service.

Areas (VET and Applied Subjects)

The VET and Applied subject areas requiring Practicum Visitors include:

- VET Agribusiness
- VET Engineering Technology
- VET Hairdressing and Beauty Therapy
- VET Hospitality
- VET Media Literacy
- VET Textiles and Fashion
